This position is based at the agency's Guelph and county locations. Some travel required within the region. Staff who travel to conduct business of the agency will be paid at the current CRA mileage rate. Opportunities to increase to full-time hours or a permanent pending on clinical and programing needs.

- Be comfortable leading a group, a workshop, a project, or a program.
- Complete client documentation in a timely and professional manner.
- Ensure a holistic, quality approach to client care consistent with Compass' Mission, Vision, Values.
- Ability to provide services in French and/or second language (in addition to English) will be considered an asset.
- Available to work flexible hours (evenings and/or weekends), required.
- Conduct/Administer single session therapy, EAP and FFS programs.

- Registration in good standing with a regulatory college in Ontario, whose members may practice the controlled act of psychotherapy.
- 2-5 years counselling experience.
- Demonstrated knowledge and understanding of therapeutic theories as they relate to anxiety/mood related disorders, intimate partner violence and trauma.
- EMDR training is an asset.
- Demonstrated proficiency in operation and use of a computer, related technologies and software required for the role(s).
- Ability to work both independently and as part of a team.
- Knowledge of the social service and health sectors, including (but not limited to):
  - Features of conditions as listed in the Diagnostic and Statistical Manual of Mental Disorders (DSM-V).
  - Clinical assessment tools.
